
6. That the school will not open classes under CBSE pattern particularly class XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation and examination byelaws and the circulars issued by the Board from time to time. 
